Artful meets with individuals and small groups both in person and via Zoom.

Artful aims to help people transform their habitual patterns (behaviors, thoughts, choices) by sharing creative practices, establishing healthy boundaries, releasing conditioning/programming, and learning the arts of allowing, noticing, slowing down, and soulful living. If you're new to making art, we gradually introduce some foundational practices like simple contour drawing, art journaling, mind mapping, and wisdom cards.

There is an art AND a science to recovery coaching. and combines it with the science of recovery coaching - asking good questions, listening actively, and treating you as your best resource. Artful adopts a non-clinical approach to transformation through the arts and leads with curious compassion while creating space for you to heal and form new neural pathways.





<u>Description:</u> Coastal Community Behavioral Health (CCBH) is a full-service outpatient substance use disorder treatment clinic specializing in the medical treatment of addiction as part of a comprehensive treatment program centered around individual counseling, group therapy, case management, and individual treatment planning. CCBH is a regional provider serving Southeast Coastal Georgia (St. Marys, Kingsland, Folkston, Brunswick) Metro Jacksonville FL, and Nassau County FL (Fernandina Beach, Yulee).

<u>Services:</u> CCBH specializes in Medication Assisted Treatment through the use of FDA approved medications including Methadone, Suboxone and Vivitrol to help those we serve reach sustained recovery. In addition to the treatment of Opioid Use Disorder, CCBH also provides treatment for individuals and families seeking help for addiction to other substances (alcohol, cocaine, amphetamines, benzodiazepines, nicotine). Licensed professionals with many years of comprehensive addictions treatment experience are here to provide an unequaled quality of care.

# Doc's Place Recovery residence for young men

<u>Description:</u> Doc's Place is a long-term structured residence for young men recovering from drug and alcohol abuse. Doc's Place provides a **safe & structured** living space for young men who are attempting to recover from drug and alcohol use. Residents of our program (12-step based) are provided with opportunities to address their psychological, spiritual, and physical health daily through structured programming proven to be successful for men in recovery.

<u>Services:</u> Group counseling facilitated by a fully licensed clinician; Individual assessment & therapy; Family therapy; 24/7 on-site staff; Structured activities & group learning opportunities dictated by residents; Weekly & on-the-spot drug testing.

Admission Criteria: Before acceptance into the program prospective residents must be physically, mentally, emotionally, and behaviorally capable of functioning in a residential setting and must not present a danger to himself or others in any capacity. Prior to entry, residents must have abstained from alcohol and/or drug use for at least twenty-four hours immediately preceding admission to the program of Doc's Place. In most cases residents will be required to complete detox prior to acceptance into our facility. We are happy to refer residents to reputable detox facilities within driving distance.

To be accepted into Doc's Place residents must commit to a minimum of 6 months length stay with the understanding that program completion requires at least 1 year stay. An entry fee of \$4,500.00 is due upon admission into Doc's Place, to be paid by support network or the resident himself. Entry fee includes the resident's first four weeks (first month) rent, groceries, and utilities.

<u>Helpful Information from Resource:</u> For residents that stay for at least the one-year requirement for completion, 60% maintained long term recovery. For those who stay between 16 and 18 months, over 80% maintained long term recovery. Our statistics include every single man that has come through whether for a few days or until completion and we don't assume the continued sobriety of former residents we have lost touch with. The positive statistics reflect residents we know to be sober and still involved in recovery.

We provide a full continuum of BH/SUD/IDD services and treatments directly and through referrals for people in need, without discrimination.

Services: In Glynn County, Gateways CSB provides the following services for addictive diseases in Adults: Individual, Group, and Family Counseling; Nursing Assessment and Care; Psychiatric Evaluations and Care; In-Patient Crisis Stabilization and Intervention; Intensive Outpatient Group Counseling; Community-Based Treatment; Housing Assistance; Residential Treatment; Supported Employment & Job Coaching; Pharmacy Assistance; Coordination with Primary Care Providers. For addictive diseases in children and adolescents: Individual, Group, and Family Counseling; Nursing Assessment and Care; Psychiatric Evaluations and Care; Community-Based Treatment; Coordination with Primary Care Providers; Pharmacy Assistance.

<u>Admission Criteria:</u> Gateway is a public agency created by state law to provide mental health, developmental disabilities, and substance use disorders.

<u>Referral Process:</u> None. You can walk-in to the Outpatient Center in Camden, Glynn, Liberty, Chatham, or Effingham counties during open access hours. Open Access hours vary by clinic. Please call (866) 557-9955 between 8:00 AM and 5:00 PM Monday – Thursday for available hours for initial intake.

<u>Helpful Information from Resource:</u> Gateway Community Service Board charges based on a sliding fee scale in accordance with Georgia's Department of Behavioral Health and Developmental Disabilities Policy. The fee scale is based on family income and ability to pay. No one will be denied access to services due to the inability to pay.


<u>Description:</u> A behavioral healthcare hospital providing mental health and recovery services for adolescents, adults, and senior adults.

<u>Services:</u> Adult Treatment Programs: inpatient mental health, inpatient detox & rehab, intensive outpatient (IOP), partial hospitalization (PHP). Adolescent Treatment Programs: inpatient mental health, inpatient detox. Senior Adults. Military. Telehealth.

Admissions Criteria: Walk-ins are welcome, but we encourage individuals needing help, their loved one and/or their healthcare provider to CALL US FIRST at 1-800-821-7224. We can help determine the most appropriate level of care needed and options available here or elsewhere. Generally, we admit patients who are able to participate in daily program activities, are independent with activities of daily living with minimal assistance and can reasonably be expected to improve their level of functioning. Patients admitted to our hospital must meet one or more of the following criteria:

- Exhibits behavior that is threatening or harmful to self or others
- Requires continuous skilled or medical monitoring for severe psychiatric crisis or chemical dependency withdrawal and detoxification
- Is severely impaired by psychiatric crisis or chemical dependency
- Is ordered for admission for 48-hour observation and assessment via a legal or court order

<u>Helpful information from the source:</u> Our mission is to provide exceptional, compassionate mental health and addiction treatment to teens, adults and seniors through quality inpatient and outpatient programs and services. Saint Simons By-The-Sea's staff is highly trained and has experience in substance use detoxification and treatment, recovery, and behavioral health treatment. 
